## Hisako O'Rourke

Missouri Children's Division, St. Louis County Nominated by Jennifer Lavelle

#### "She doesn't just do it ... She believes it!"

Hisako (Sako) O'Rourke is regarded as the consummate social worker. She has been with the Missouri Children's Division for 13 years and works out of the St. Louis County office. A strong advocate for the children in her caseload, she thinks outside the box when finding ways to create healthy and successful family placements. Sako's reputation with community members is exemplary. They trust that she will do everything she can for the children. She often is relied upon to take the most difficult cases, knowing she will do so with thoroughness, empathy, concern and strength. Sako is the kind of worker who does more than what is expected, and has been instrumental in getting children in her caseload services they might not have otherwise received. Her commitment is illus-



trated in the story of a girl in her caseload who had over 30 placements in her 16 years of life. While the youth was in a residential facility due to trust issuerelated behaviors, her adoptive family moved to Washington, D.C. Sako continued to follow her case and arranged for a residential facility in Washington so the family could work toward reunification.

When the family chose not to pursue reunification, Sako continued to advocate for the girl and eventually secured a transitional housing placement for her back in the St. Louis area. Sako realized that she was now the only adult in this child's life who was still looking out for her best interest, and she wore this burden with a heavy heart. Without Sako on this case, this youth would have turned age 18, and found herself completely alone. Sako gave her a chance at a healthy adulthood; Sako saved this child.

# **Bev Schaefer**

#### "She has incorporated her job into her life's mission!"

Bev Schaefer has been serving families as a foster care worker for Lutheran Family & Children's Services for almost 30 years. Before that, she and her husband Rich were foster parents to more than 50 young people and since have adopted two children. With LFCS, Bev has supervised over 900 children. She has incorporated her job into her life's mission. Known for the warmth and compassion she exudes, she makes people immediately feel at ease, whether they are infants, children, teens or adults. Her personal experience as both a foster and adoptive parent has made her an empathet-



ic and effective advocate for anyone touched by these experiences. When she was a foster parent, she would be asked often to meet with birth parents whose children were going to be placed in foster care, to ease their fears about the negative image of foster parents. After meeting with Bev, birth parents would

feel confident that their child was going to receive loving care in a safe family environment. She selflessly makes herself available to foster parents 24 hours a day. Once, Bev volunteered to transport a child to Arizona for a sibling placement, so the adoptive parents, who had several other children, did not have to make the trip. She radiates positive energy, never loses her patience, and is a tireless champion for children.

She tries very hard to give the children she fosters the same opportunities she gave to her own children. Evelyn has helped two of the girls purchase automobiles, and she makes sure they understand the importance of budgeting their money, paying bills, paying for insurance and working. She hosts family support team meetings in her home and she has direct contact with many of the birth parents, even after the girls go home. Evelyn not only provides emotional support to the girls, but she talks with birth parents and other family members to help them manage the girls and their behaviors.
