They have taken this child on family trips both in state and out of state with their own biological children. Tiffany and Robert strongly believe in reunification; they have asked the mother to come to the doctors' appointments and have been mentoring the mother on how to care for her son. There have been times when the child has been hospitalized due to his medical needs and at least one of the

ensure he receives the best medical attention and support.

About their service as foster parents, Tiffany and Robert said, "Our calling to become foster parents came from our desire to follow Jesus'



instructions in the Bible to care for the orphans and the helpless in the world. It's rewarding to know we are teaching our biological children at a very young age to care for others. It's also a privilege to be able to help a young child learn that a troubled past doesn't mean a troubled future."
