

Dr. Shanté M. Lampley

Dr. Shanté M. Lampley is the Chief Deputy Juvenile Officer for the 22nd Judicial Circuit of Missouri, Child Protection Department. In this capacity, she oversees four Child Protection and Permanency Units as well as the Mediation and Special Court Services Unit. She has held this position for 15 years. She has previously worked as a Deputy Juvenile Officer in the Child Abuse and Neglect Unit, Assistant Supervisor for the Truancy Unit, Family Court Mediator, and Supervisor of the Mediation and Special Court Services Unit. She has held positions as Director and Liaison for the Family Subcontracted Services Program, and St. Louis City Site Coordinator for the Annie E Casey Juvenile Detention Alternatives Initiative. While she has worked at the 22nd Circuit Court for 26 years, Dr. Lampley has been an advocate for children's safety and well-being for over 31 years.



Dr. Lampley is a 2017 Missouri Foundation for Health Leadership Fellow. She has served in the past as adjunct faculty in Criminal/Juvenile Justice for Harris-Stowe State University and St. Louis University. She is a member of the St. Louis Regional System of Care Council, St. Louis Child Abuse and Neglect Network and Coalition against Trafficking and Exploitation. Dr. Lampley is a current board member of MGC, Elevate Inc. and the Office of State Courts Administrator-Juvenile Division Education Committee.

Dr. Lampley received a Bachelor of Science Degree in Child/Family Development, a Master of Arts degree in Criminology/Criminal Justice and a Doctor of Management and Organizational Leadership. She has completed Basic and Advanced Civil and Divorce Mediation Training. Dr. Lampley received both a Management Certificate and Supervision Certificate from Southwest State University, Management Development Institute. She also participated in the Advanced Juvenile Justice Management Institute, which was certified by the Louis W. McHardy National College of Juvenile and Family Justice.

What makes the Hills exceptional is their BIG Hearts. They personify what it truly means when you say someone has a loving home. They are always willing to help with some of our harder to place youth. The care that they both show the youth in their home is heartwarming and is a real-life example of fostering that seeks to address past trauma and provide aide for healing.



Whenever a youth needs something, they just go out and get it. It doesn't matter if the youth need shoes, clothes, a coat or jacket, or whatever the need is, they just get it done. They are also not that foster parent that comes back saying they need to be reimbursed, or they can't take them to get anything because they are waiting on the youth's Children's Division Worker to send the money. They see the need and just get it done.

Shanna and Maurice Hill are an exceptional team, working tirelessly to make sure everyone in their care is thriving. You can see the impact this makes for the youth when you visit their home.

An example that showcases the Hill's commitment to the youth in their care and how they are always exceeding expectations, is a conversation that was had by one of the youths in the home. He is an older youth and he mentioned some of the challenges they were facing trying to find a job and access resources and how the people assigned to their case to assist them were not providing him with the help he needed. He then stated, "the only people helping me is Shanna and Maurice and that's because they love me." He said it so confidently and nonchalantly like it was no big deal. But it was a big deal because how many youths can feel that love and just know it from their foster parent. He knows that he is loved by those entrusted to care for him.

Bill and Elizabeth Jackson

Elizabeth and Bill Jackson are therapeutic foster parents who genuinely and truly cares about all their foster kids. Elizabeth is a great advocate and will do whatever is best for her kids. She assures that contact and visits take place even if it means she has to transport to and from far distances. Bill and Elizabeth always bring their foster kids on vacation and to family parties instead of using respite. Elizabeth attends all of her kids' events and ensures all of them get their one on one time with her. She will work with tough kids with a variety of diagnosis and behaviors such as aggression.



Bill is a supportive and strong male role model for the TFC youth that they foster. He loves teaching them things such as cooking and working on cars. He loves doing outdoors activities with the youth and works well as a team with his wife Elizabeth. He attends as many activities as he can in which the youth participate in and has a great sense of humor.

Elizabeth is a very patient foster mom who never gives up on a youth despite what may be thrown her way. She has on going relationships and remains a support in foster youth's lives even after they transition out of her home. Former foster youth still come over on holidays and for visits as well as call. She goes above and beyond always.

Toni is an amazing advocate for children and families. She is kind, compassionate and works from a strength-based lens. She uses all her skills in training a new generation of child welfare practitioners. She treats families and staff with respect and encourages growth and vulnerability. Toni sees potential in everyone and is an excellent facilitator, bringing people together to meet a common goal.

For the past year Toni has been carrying a caseload of 18 children in foster care. She has a young person on her caseload who is struggling with a multitude of issues. He has disrupted several placements, been hospitalized several times and has been arrested on adult charges. Toni has spent countless hours with him, processing his trauma so he can gain insight into his behaviors. She is a fierce advocate for him in treatment meetings, court, and with placement providers. As a result of her efforts this young person's outcome is bound to be better. This young person has developed trust in Toni which is rare as he has resisted trusting relationships since he has been in care.

Reggie Jones

Reggie Jones has committed his life to improving the lives of our youth by implementing programs at the Herbert Hoover Boys and Girls Club. He has been employed at The Boys and Girls Clubs of Greater St. Louis (Herbert Hoover), where he serves as Club Director for 28 years. As a coach I have been given the opportunity to see the improvements first hand that Reggie has implemented to improve the lives of the children and families at Hoover.

Reggie Jones has been a member of Iota Phi Theta Fraternity, Inc. since 1992. He served as President of the St. Louis Junior Football League (an organized tackle football league that serves over 3,000 children in the St. Louis metropolitan and bi state area) from 1999 to 2013. Mr. Jones has been elected to five offices. The Riverview Gardens School Board in 2010, Collector for the City of Dellwood in 2011, Dellwood Alderman for the 3rd Ward in 2012 and currently serving in his 6th term (elected in 2013) as Mayor of Dellwood, and in 2020 he was elected to the office of Ferguson Township Committeeman.

The Mayor Reggie has been a valuable asset to the community as a whole. Through his leadership, I have watched the community grow to fulfill the needs beyond expectations for the children and the families in Dellwood. His influence in the community has been so strong that no one would challenge his leadership as he has ran unopposed in his previous elections. Reggie has truly been a blessing to many children and families that are able to benefit from his vision and promise to improve the lives and the future of many generations to come.

Dr. Allisha Jones-Pickens

Dr. Allisha Jones-Pickens is the Founder/Executive Director of Community of Hope, a non-profit organization that serves teenage mothers, ages 11-18 under Grant funding and 19-22 under community volunteers, in the St. Louis area; helping them create better environments through case management, mentorship, referrals and direct assistance, for themselves and their children.

It was during her own incarceration in the Prison System that Allisha began to face the obstacles of her own past. It was also where she learned that she, like many other women and young adults, could not move forward because they were still mentally and emotionally imprisoned by the hurts, pains and events stemming from a troubled "yesterday." As a domestic violence and sexual abuse survivor herself, Allisha speaks through various forms of media outlets, such as Podcasts, Workshops, school conferences, retreats and written novels, to promote positive mental health and well-being.

Being a teenage mother at fourteen, Allisha founded Community of Hope to provide young girls a safe space, a resource hub for services and a place where women who have traveled the same path as the young mom's we serve, have a place to give back to the community through shared experiences.

She has been a great support and advocate to the PACT-STL team and parenting programs!
